A meeting of the West Virginia Northern Community College Board of Governors was held on Thursday, June 26th in the Project Best Executive Conference Center on the Wheeling campus.

1. Call to Order

Ms. Carenbauer called the meeting to order at 8:35 am.

2. Roll Call

3. Board Chair Report

4. President's Report

Dr. Mosser stated that at Commencement in May, there were 255 graduates earning 274 credentials including 178 Associate degrees plus 83 (one-year) certificates. The Form Energy CEO, Mateo Jaramillo, was our Commencement speaker.

There is still ongoing construction all around us. Contractors have replaced structural steel above the three arched center windows on the B&O. Masonry work is being repaired or replaced. There is an anticipated completion date of July 31st for this work.

Work is underway to install and launch Element 451, our new CRM.

Due to our rapidly growing enrollment in Weirton, Cabinet held a retreat and developed a tentative plan to repurpose some of the underutilized space on that campus. With the DOL MAPS grant, we are working with industry to align our programs to meet their needs.
