# OFFICIAL MINUTES BOARD OF GOVERNORS MEETING WEST VIRGINIA NORTHERN COMMUNITY COLLEGE Thursday, September 26, 2013 -- 5:00 p.m. -- B&O Board Room

A meeting of the West Virginia Northern Community College Board of Governors was held on Thursday, September 26, 2013 in the B&O Board Room on the Wheeling Campus.

#### 1. Call to Order

Dr. Darrell Cummings convened the meeting at 5:00 p.m.

#### 2. Roll Call

## 3. Approval of Minutes (May 23, 2013 and August 22, 2013)

## A. State Budget

Dr. Olshinsky reported the College is preparing for the 7.5% budget cut proposed by the state for January 2014.

# B. Some Highlights of the President's Activities for the Month of September

- Dr. Olshinsky reported he worked with College personnel to determine the direction for on-line programs. The goal is to have two or three programs operational by fall 2014.
- Grants were received for robotics and technical scholarships. The funding will assist Northern in establishing itself as a leader in technology education for the region.
- The college community has the full HLC report. The report will aid in systemic changes to the College for the next ten years.

## -- Status of Credential Project - Higher Learning Commission

Dr. Olshinsky informed the Board the full 2013 HLC Report and the Executive Summary is posted on the College's Web page. Ms. Dudash will email Board members the link to the reports.

Dr. Riley reported the HLC team recommended Northern review faculty credentials to assure all necessary information is in faculty personnel files and instructors meet qualifications required to teach specific subject areas.

Program directors met to review each program and course taught to determine credentials needed in order to complete the faculty personnel files. Once credentials are identified, the Vice President of Academic Affairs will meet with the office of Human Resources to make sure personnel files are complete and changes are made as needed. A report will be submitted to HLC by the end of November on progress to date regarding faculty credentials and Northern's plan to validate credentialing as part of its hiring process.
