Registered Nurse Educational Requirements Alignment with Other States **Initial** LPN Licensure

On July 1, 2024, The U.S. Department of Education has implemented new regulations which requires the West Virginia Northern Community College's Licensed Practical Nursing Program to provide a list of all states/jurisdictions disclosing if the institutions curriculum meets other state educational requirements for **initial** professional licensure.

1. This information is only for **initial** licensure by exam requirements for the state listed.
2. This information DOES NOT apply to transferring a WV LPN License by endorsement to another state.
3. It is recommended that students contact the Board of Nursing in the state in which they would like to be initially licensed for more specific information.
